Multistakeholder Coordination Meeting for J&K floods

Agenda

- To discuss:
 - current status of J&K floods, detailed coordination plan including logistics planning
 - Joint Rapid Need Assessment (JRNA)

Proceedings:

The meeting started with a round of introduction by participants (list of participants is enclosed as an annex).

Situation Analysis:

- The videos and photos reflecting situation of Jammu and Kashmir flood was shown
- Facts and Figures were shared indicating that over 2500 villages in 15 districts have been affected
- Tarpaulin sheets are less in no. hence families are living in bus and trucks which are immobile
- Immediate needs are WASH, Food (daal, cereal, sugar), Medicine, Fuel, NFI, Tarpaulin, tents, blankets, sleeping beds, etc.
- Communication is the biggest problem. Communication network damaged in Srinagar but in some area Aircel connection is working
- Local relief is going on but currently communities are using tap water, which will exacerbate illness in future

Suggestions:

- Members suggested for having a centralized warehouse in J&K, one Coordination hub in Jammu and one in Srinagar
- Assessment is needed to identify gaps; JRNA will help to assess the situation and identify **life saving emerging needs**.
- There is a need to identify IDPs and their needs
- Since JRNA will take time, secondary data analysis will help to identify immediate needs for relief response
- Local procurement is possible in Jammu and from nearby states like Punjab (Pathankot)
- Mapping of functional markets Market analysis so as to decide response strategy (CASH transfer or material supply)
- Request to NDMA to issue guidelines to NDRF that children, women, and infirm should be evacuated first
- Dignity kits, delivery kits, insulin and other medications should be mobilized immediately

1. Coordination

- Structure and Processes for Coordination was shared and discussed
- Coordination process is started at national level. URS matrix is shared and links are provided below:

URS Matrix (Resource Committed): Jammu and Kashmir Flood 2014

URS Matrix (Resource Planning): Jammu and Kashmir Flood 2014

- Requested agencies to upload information in URS matrix online (links shared above). Share information with other to upload information in URS matrixes sheets
- Multistakeholder coordination platform is established, requested members to bring more corporates and other stakeholders on this common coordination platform
- Targeting and Minimum Standards was shared and discussed. Emphasized to ensure minimum specification of items, appropriate and cultural specific to Jammu & Kashmir
- Members suggested to add Rohingias Muslims (Myanmar displaced community),
 Migrant workers, Orphans, Homeless, Elderly and visually disabled as groups to be targeted first
- Plan may be shared with Resident Commissioner, J&K

2. Assessment

- Planning for Joint Rapid Need Assessment (JRNA) was shared and discussed
- Coordination process at Sphere India consists of:
 - > Inter Agency Coordination Committee
 - ➤ Sectoral Committees (Shelter, Protection and Education, Health, WASH and Food & Nutrition)
- It is important to understand needs in quantifiable form
- Nominate people for assessment and deploy trained personnel for assessment
- It was suggested to capture **migrants** also during the assessment
- Language issues (Kashmiri & Pahari) in districts near Pakistan border should be taken care of during assessment

3. Logistics

- Logistics coordination was shared and discussed
- There is a need to create secretariat or hub i.e. centralized warehouse facility in Delhi/Srinagar or wherever required (can be explore near to Delhi airport, Transport Corporation of India (TCI) etc.)
- Timeline for entry and exit point of warehouses is to be planned

• Minimum standards should be followed for logistics planning and relief response keeping NGOs mandate aside and working together in coordination

Decisions:

- 1) Teams formed for:
 - Secondary analysis of needs: Sandhya (Action Aid), Derek (ADRA), Eilia (Care India), Anwar (OXFAM), Sibghatullah (Islamic Relief)
 - Operational modalities/logistics strategy: Mangneo (IGSSS), Loveson (WV), Kaustubh(Red Cross), Balaji, Babita Aleck (Caritas India), Saurav (Tata Group)
- 2) Immediate needs identification through Secondary data analysis will be done by Secondary analysis of needs group
- 3) Liaisoning with State Government (Army and Civil Military) with the support from NDMA
- 4) Coordination center to set up at state and district level also.
- 5) To identify common warehouses at Delhi, Jammu Srinagar and other places wherever required.
- 6) Dates for orientation on Joint Assessment tools and field visit will be plan once the accessibility issues are resolved.
- 7) To list emerging top priority needs.
- 8) Sphere India sectoral committee to develop minimum standards for each sector in context of Jammu and Kashmir.
