- 1.1 SEWA, Save the Children, EFICOR have undertaken needs assessment in Shiv Vihar, Rajiv Nagar, Mustafabad, Bhagirathi Vihar, Chand Bagh, Khajuri Khas and Sri Ram Colony.
- 1.2 Save the Children has undertaken rapid market assessment.

Actions: 1.1 Helping Hands to connect Sphere with FIDUS, an organization currently active in livelihood and rehabilitation

- 1.2 Sphere India to receive and share among the group the various initiatives undertaken by the organizations so as to avoid duplicity.
- 1.3 Save the Children to share GIS coordinate of their area of activity.

Key Discussions:

2.1 With regards to providing rehabilitation, it was suggested that organizations tally their targeted beneficiaries with the government's database of victims entitled to compensation. *Follow-up:* The portal shall be online within the next few days.
